A record high of more than 34 million foreign-born persons reside in the United States. Just in the past 20 years, about 23 million newcomers have arrived. This immigration growth has had a profound impact


on the Church, with as many as 300,000 Catholics arriving each year from all regions of the world. It is estimated that 42% of Catholics in the United States today are foreign born.

At the same time, U.S. immigration laws and policies have become increasingly restrictive and even harmful to some immigrants and asylum seekers. Between 8 and 10 million people in the U.S. live on

the margins of our society for lack of proper immigration documentation. U.S. residents who want to reunite with close family members must often wait 10, 15, and even more years before visas for their relatives become available. Border enforcement strategies employed along our southern border have resulted in thousands of deaths. And, asylum seekers who flee persecution in their home countries and look for safe haven in the U.S., instead find themselves detained as criminals for lengthy periods.

The bishops believe U.S. immigration policy should protect the human rights and dignity of newcomers, as well as provide legal and secure means of entry for prospective immigrants and asylum seekers. The bishops also acknowledge with concern a growing public sentiment that has led to these more restrictive immigration laws and policies. The bishops have called for broad reforms of U.S. immigration laws and policy. In a landmark pastoral letter, *Strangers No* 

Longer: Together on the Journey of Hope, issued in January 2003, the U.S. and Mexican bishops outlined the elements of necessary reforms. These included legalization for the undocumented who



Additionally, the bishops recognize that the conditions that compel people to leave their homes out of desperation and lack of opportunities to provide for themselves and their families, must be addressed if an effective and comprehensive response to migration is to be achieved.

Therefore, the Catholic Campaign for Immigration Reform will work closely with the Catholic Campaign Against Global Poverty, initiated by the USCCB Office of International Justice and Peace and Catholic Relief Services. That Campaign aims to reduce poverty through trade, aid and debt reforms. The Immigration Reform and Global Poverty campaigns are integrally related in that one addresses the rights and needs of migrants in the U.S., while the other addresses the rights and needs of persons living in their native countries.

#### The Campaign Objectives

The Campaign has four primary objectives:

(1) to educate the public, especially the Catholic community, including Catholic public officials, about Church teaching on migra-

tion and immigrants; (2) to create political will for positive immigration reform; (3) to enact legislative and administrative reforms based on the principles articulated by the bishops; and (4) to organize Catholic net-

works to assist qualified immigrants obtain the benefits of the reforms.

## Congress Ready to Address Immigration Reform

Congressional leaders have indicated that Congress is likely to address the issue of immigration reform before the end of the 109<sup>th</sup> Congress in 2006. It is expected that the House of Representatives will consider legislation as early as December and that the U.S. Senate will address the issue in early spring, 2006.

The Homeland Security Committee in the House of Representatives is writing legislation focusing on border security, which could be before the full House by the first week of December. It is unlikely that the House will consider legislation focusing on earned legaliza-

tion, a temporary worker program, or family reunification.

In the Senate, however, the Senate Judiciary Committee will consider comprehensive immigration legislation in February. It is expected that the legislation considered by the committee will include elements of several bills introduced in the Senate, including provisions of the Secure America and Orderly Immigration Act, introduced by

Senator John McCain (R-Az.) and Senator Edward M. Kennedy (D-Mass.).

Once the Senate passes legislation, bills passed by both chambers will be reconciled in a conference committee composed of House and Senate members. It is unclear as to when a final bill will be sent to the president. Since 2006 is an election year, it is possible that the issue could be mired in election-year politics and postponed until a future date.

During the process, the JFI campaign will focus on influencing members of both the U.S. Senate and the House of Representatives. Over the next few months, the JFI campaign will send action alerts to diocesan contacts at significant points in the debate.

In order to pass legislation which most closely comports with principles outlined by the U.S. Catholic bishops, it will be important to minimize the enforcement-only approach supported by the House of Representatives and maximize the comprehensive approach supported by the U.S. Senate. The JFI campaign will keep diocesan contacts and others of breaking developments as the process unfolds.

## Justice for Immigrants In Chicago

(The following was submitted upon request and has been summarized in an effort to reflect the most relevant information)

Over the course of many decades, the Archdiocese of Chicago has been very blessed to have Cardinals who are proactive leaders in promoting social justice on behalf of the most vulnerable in our society. This year, after the USCCB launched the Justice for Immigrants Campaign, Cardinal George and the Archdiocese welcomed the opportunity to join a national effort towards immigration reform. The following report summarizes our office's related strategies and work performed to-date.

Formed an archdiocesan task force with 20 leaders representing various offices and net-

works (Catechesis, Deaconate, Respect Life, Hispanic, European and Asian Catholics, Pastoral Associates, Catholic Charities etc.). This task force develops education, advocacy and media strategies to create awareness on the need for immigration reform.

Conducted first training with participation of 40 non-immigrant and immigrant parishes to start dialoguing on this issue. As a result, 10 "Sharing Parish" partners began

more extensive dialogue and actions on this issue.

- Formed a Pastors for Justice for Immigrants Network currently with over 20 pastors from nonimmigrant and immigrant parishes in the city and suburbs who committed themselves to: I) highlight immigration issues at their homilies during the Liturgical Calendar seasons, beginning with the Advent and Christmas seasons; 2) promote the use of educational resources (Advent, Lent, Pentecost, etc.) among religious education program, liturgy teams, etc.3) participate in post-card writing campaign to President Bush and Speaker of the House, Dennis Hastert. They will mail post-cards to the White House, and the ones for Dennis Hastert will be delivered to his office by a group of pastors.
- Sought support from archdiocesan clergy leadership during their executive committee of the Presbyteral Council and were invited to do a presentation to the Presbyteral Council at their November retreat.
- Developed "take action" flyers in English, Spanish and Polish introducing the USCCB campaign encouraging Catholics to contact their elected officials. Distributed flyers in all parishes.
- Highlight "online" take action strategy by having an interactive icon in homepage of archdiocesan website which only takes three minutes to send an e-mail to congress and elected officials.

The Catholic Legal Immigration In 1988, the United States Network, Inc. (CLINIC) seeks to affirm the dignity of all newcomers. Its primary mission is to provide a full range of legal and non-legal support services to Catholic Charities' and diocesan legal immigration programs. These local Catholic programs directly represent poor immigrants with a focus on reunification of families and protection of those fleeing persecution or civil unrest.

Conference of Catholic Bishops (USCCB) established CLINIC as a legally distinct 501(c)(3) organization to support a rapidly growing network of community-based immigration programs.

CLINIC's network originally comprised 17 programs. It has since increased to 153 programs in 260 office locations. The network employs roughly 1,000 attorneys and

"accredited" paralegals who, in turn, represent more than 100,000 low-income immigrants each year. CLINIC and its member agencies serve low-income immigrants without reference to their race, religion, gender, ethnic group, or other distinguishing characteristic.

(CLINIC) Board of Directors resolved to make comprehensive immigration reform, with special emphasis on legalization, a major public policy priority within the Church. Many other national Catholic institutions have also made legalization a policy priority.

As part of the Church's response, a divers group of Catholic organizations with national networks have decided to join the United States Conference of Catholic Bishops' *Justice for Immigrants: A Journey of Hope campaign* designed to unite and mobilize a growing network of Catholic institutions, individuals, and other persons of good faith in support of a broad legalization program and comprehensive immigration reform.
